1. PURPOSE

To manage and control illegal use of firearms, hunting, fishing, trapping and collecting activities to ensure that naturally occurring native species, their diversity within species and their natural distribution are maintained.

2. SCOPE

This SOP applies to forest management workers who responsible to manage and control illegal use of firearms, hunting, fishing, trapping and collecting activities.

3. RESPONSIBILITIES

The Forest Manager, Assistant Forest Manager and Forest Supervisors are responsible for:

- Manage and control illegal activities such as illegal use of firearms, hunting, fishing, trapping and collecting activities.
- Monitor Asrama Raya Sdn Bhd (ARSB) HS Petuang-Tembat Concession against the illegal activities.
- Ensure the implementation of this procedure

4. PROCEDURE

4.1. Managing and Controlling Illegal Use of Firearms, Hunting, Trapping, Fishing and Collecting Activities with Forest Workers

- 1. Inform forest workers for strictly do not conduct any illegal activities such as illegal use of firearms, hunting, trapping, fishing and collecting activities within ARSB Forest Concession.
- 2. Educate forest workers regarding the offence of illegal use of firearms, hunting, trapping, fishing and collecting activities.
- 3. Conduct awareness programs such as talk and training regarding the law and offences of the illegal activities once per year.
- 4. Display poster regarding hunting, fishing and collecting forest products prohibition within ARSB Forest Concession and logging camp.
- 5. If any illegal hunting case is found by forest worker, the worker needs to report the case and submit the form 'Borang Pelaporan Pencerobohan atau Aktiviti Haram dalam Konsesi ARSB' (refer to Appendix 1) to Forest Supervisor (*Kepala Hutan*).

4.2. Managing and Controlling Illegal Use of Firearms, Hunting, Trapping, Fishing and Collecting Activities with Local Community

- 1. Interview or conduct survey with the local community whether they are using firearms for hunting or not within ARSB Forest Concession.
 - Inform the local community about the offences of having firearms and conducting hunting without permission.
- 2. Educate local community regarding the offence of illegal use of firearms, hunting, trapping, fishing and collecting activities.
 - Raise public awareness on the illegal activities by conducting awareness programs regarding the regulations and offences of the illegal activities.
 - Put up a banner in the Kampung Payong as a warning sign to local community for illegal use of firearms, hunting, trapping, fishing and collecting activities.
 - Place banner and signboard regarding hunting prohibition, fishing prohibition, collecting forest products prohibition within ARSB Forest Concession at Kg. Payong.
- 3. Engaged with local community from Kg. Petuang for helping in monitoring ARSB Forest Concession from encroachment and illegal activities.
- 4. If any illegal activities are found by local community, the local community needs to report the cases and submit the form 'Borang Pelaporan Pencerobohan atau Aktiviti Haram dalam Konsesi ARSB (Kg. Payong)' (Appendix 2) to Forest Manager.

4.3. Managing and controlling Illegal Use of Firearms, Hunting, Trapping, Fishing and Collecting Activities with Stakeholders

- 1. Invite stakeholders for conducting briefing or talks regarding illegal activities such as illegal use of firearms, hunting, trapping, fishing and collecting activities to forest worker and local community.
 - Eg. Invite Department of Wildlife and National Parks of Peninsular Malaysia (PERHILITAN) for conducting briefing / talk and training of conservation and protection of wildlife to forest workers.
- 2. Collaborate with government agency such as TSFD and Terengganu State PERHILITAN in monitoring ARSB Forest Concession from encroachment and illegal activities (illegal use of firearms, hunting, trapping, fishing and collecting activities).
- 3. If any illegal activities / hunting is found within ARSB Forest Concession, ARSB need to report the cases to government agency such as Terengganu State PERHILITAN for further actions.
- 4. After received report or complaint from ARSB, Terengganu State PERHILITAN start patrol the ARSB Forest Concession for the encroachment and illegal hunting.

4.4. Controlling Illegal Use of Firearms, Hunting, Trapping, Fishing and Collecting Activities

- 1. Install a boom gate at the concession entrance to control access to ARSB Forest Concession and prevent hunters and outsiders to enter ARSB Forest Concession.
- 2. Place 'No hunting' signage at the main entrance and operational areas to provide warning against the illegal hunting.
- 3. Set up camera trap in several areas of ARSB Forest Concession to detect and monitor encroachment and the illegal activities.
- 4. Collaborate with TSFD, Terengganu State PERHILITAN and police for controlling the illegal activities (illegal use of firearms, hunting, trapping, fishing and collecting activities).
- 5. Engage with local community for helping in monitoring ARSB Forest Concession from encroachment and illegal activities.
- 6. Forest workers must report to Forest Supervisor/ 'Kepala Hutan' if found any illegal activities happened in ARSB Forest Concession.

4.5. Enforcement of Illegal Use of Firearms, Hunting, Trapping, Fishing and Collecting Activities

- 1. All of the forest workers and public must follow the act and regulations of Malaysia as stated in Arms (amendment) Act 1960 (Act 206), Wildlife Conservation (amendment) Act 2010 and Fisheries (amendment) Act 1985.
 - Based on Arms (amendment) Act 1960 (Act 206) Section 3(1), subject to this Act and any regulations made thereunder, no person shall have in his possession, custody or control any arms or ammunition unless he is the holder of an arms licence in that behalf granted to him under section 4.
 - (2) Notwithstanding subsection (1), a person may carry and use arms or ammunition in accordance with the terms of a valid permit granted to him under section 4: Provided that there is in force an arms licence in respect of those arms and ammunition granted to some other person.
 - Based on **Wildlife Conservation (amendment) Act 2010 Section 9(1)**, subject to the provisions of this Act, no person shall
 - (a) hunt or keep any protected wildlife;
 - (b) take or keep any part or derivative of any protected wildlife;
 - (c) collect birds' nests;
 - (d) carry on the business of dealing;
 - (e) carry on the taxidermy business;
 - (f) import, export or re-export any protected wildlife or any part or derivative of any protected wildlife

unless he holds a licence granted under this Act.

- Based on **Fisheries (amendment) Act 1985 (Act 317) Section 8**, any person who undertakes any fishing activity, operates, or allows to be operated, in Malaysian fisheries waters any local fishing vessel for the purpose of fishing—
 - (a) without a valid licence issued under this Part;
 - (b) in contravention of any condition in the licence issued in respect of such vessel; or
 - (c) in contravention of any direction in writing issued by the Director General under this Act,

shall be guilty of an offence.

- All of the forest workers and public must obey and follow the international regulations and conventions stated in the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES, 2013), IUCN Red List (IUCN Standards and Petitions Committee. 2022).
 - Huge number of animals and plants are protected by CITES against overexploitation through international trade. Those animals and plants listed in the three CITES Appendices are not allowed to be traded, exported or imported from the country.
 - Based on IUCN Red List, those animals and plants listed as Vulnerable (VU), Endangered (EN) and Critically Endangered (CR) are strictly not allowed to be hunted and destroyed.

- 3. All of the forest workers are strictly prohibited to use firearms illegally, conduct hunting, trapping, fishing and collecting activities in ARSB Forest Concession.
- 4. The person who found to be used the firearms illegally and conduct hunting, trapping, fishing and collecting activities in ARSB Forest Concession must be send to PERHILTAN or police for further investigation and punishment.
- 5. ARSB only report the illegal activities cases to government authorities, as ARSB is only a concession holder and has no authority to arrest intruders or poachers if they found to conduct illegal activities within ARSB Forest Concession.
